Group Discussion

- 1. Meeting called to order at 7:34 PM EST and review of last meeting Group The 5/14/2024 meeting minutes were approved and will be posted on the website.
- 2. Non-Profit Updates Shawn L., Executive Director Board members are working on previously tabled projects and making progress.
 - The Annual Executive Board Meeting was held on 5/28 and 6/2/2024.
 - The next board meeting will be on Sunday, 7/7/2024.
 - A Team Leaders meeting was held on 6/4/2024, to discuss reorganizing, introducing new email accounts for team leaders, and initiating Team Leader Reporting forms.
 - The UV4SOR website has been transferred from Bluehost to Lost Swordfish hosting service, which also hosts the NARSOL website and many of their state affiliate's websites. The domain registry has been transferred to Hover.com.
 - CiviCRM will be implemented with projected training to begin this summer.
- 3. Advocacy Participation Team Kim H.
 - UV4SOR was approved for the Michigan Adopt-A-Highway project. All Michigan members are invited for a cleanup event on 7/13/2024 and Kim is hosting a picnic afterwards. The members are teaming up with a Michigan Citizens for Justice support group on this project.
 - A new Welcoming Team is being formed by Ann and Shep S. to reach out to new members after they attend their first meeting.
- 4. State Coalitions Team Kim H.
 - The team is at a crossroads and working to determine interest and direction for the immediate future. These items will be reviewed at the next meeting which will be held on 7/22/2024.

5. Communication Team – Kathy D.

- The team met on 6/7/2024 to update its purpose and goals for the future with discussion of the history of letters that have been sent, revising the UV4SOR Myths and Facts document to reflect current and accurate information, and defining a focus on families and LOs.
- Kathy D. will take over as the team leader. The date for a future meeting is pending.

6. Call to Action (CTA) Team – Elena A.

- Elena reviewed the CTA to the Louisiana legislature and is collaborating on drafting a letter to the LA governor to address the passage of SB371 (forced vasectomy).
- The HUD CTA responses were due on 6/10/2024. Feedback on this has been positive with member participation.
- The United States Sentencing Commission (USSC) is asking for informal public comment for their 2025 priorities with responses due on 7/15/2024. This opportunity has been posted in the FB group and in several federal groups. An email will be sent to all members to encourage participation.
- The next CTA will address the issue of email privileges for our LOs in federal custody.

7. Mental Health Team - Pammy D.

- Terrific Tuesdays (initially called Healing Tuesdays) will be scheduled where there is a fifth Tuesday general meeting in a particular month.
- The team is working to add a subgroup/support chat that will meet a few times a year, with five different members at a time and a MH leader. This project is in the planning stage; currently developing an introduction that will be presented to the board when it is finalized. The focus will be on providing information for resources needed and for coping strategies, giving participants a safe place to ask questions and interact with other members.
- A future project is to focus on MH intervention as a diversion program for those newly arrested.

8. No More Silence Project – Betty B.

- Betty reviewed the project's story challenge and goals. She emphasized how all stories can play a significant role in getting our voices heard.
- The next step will be to compile a list of recipients for this first stage of the project.

Social Media Team – Rita B.

The team continues to monitor the FB group and encourages advocacy posts and comments that include asks and offers for solutions to the frustrations that are voiced in posts and comments.
