- 2. Non-Profit Updates Shawn L., Executive Director

Board members meet monthly and are working on current and previously tabled projects.

- The next board meeting will be on Sunday, 8/25/2024.
- A training module has been uploaded for the CiviCRM program to get familiar with the applications, to create contact lists and reports, and to learn how it pertains to our functionality as an advocacy group. A Civi review meeting is scheduled for 8/27/2024.
- 3. Advocacy Participation (AP) Team Kim H.
 - Kim worked with Sharon and Rita to review and confirm our practices for new membership requests.
 - Kim has been working in the Civi training module to test the processes for importing member data. She is documenting her findings and sharing with Shawn L., Sharon M., Art L., and Andy S. She will work with Art to create the import data to use in a modified script to populate 100 test members.
- 4. State Coalitions Team Kim H.
 - Member Brenton T. has an annual parole requirement to fulfill shortly. Looking on the Tennessee SOTB website to learn more about the organization, he noticed the site did not include as stakeholders those who are the focus of the board. He plans to contact them to discuss including registrants as stakeholders.

- 5. Welcome Team Ann & Shep S. The team is reaching out to new members after they attend their first meeting.
- 6. Communication Team Kathy DV.
 - The team will assume responsibility for replying to and documenting correspondence that is received by UV4SOR from those who are incarcerated, and Shawn L. has forwarded the letters received. Sharon M. has developed a spreadsheet to track from whom, the facility it comes from, and the requests made by those who have reached out to the group. The team will identify themes and respond accordingly.
 - A team meeting will be scheduled in the next few weeks.
- 7. Call to Action (CTA) Campaigns Shawn L.
 - Shawn and Sharon M. mailed a letter from UV4SOR to various BOP directors and legislators addressing the problem of the federal TRULINCS email system being denied to those with a sex offense based solely on their charges, which is in violation of the BOP's program statements. The letter has been revised for use by individual members and will be made available to them along with a list of suggested recipients, with a CTA to be posted and emailed to members soon.
 - All members are welcome and encouraged to attend meetings and bring forth issues that they feel are important. Bringing information to the group for discussion and suggested action shows that advocacy starts with one person getting upset and wanting to do something about it!
 - Laura M. addressed the issue of political rhetoric in this campaign cycle where elected
 officials brag about jailing "sex offenders" and use fear triggering words to sway a vote
 towards a candidate. She would like to head up a CTA to educate targeted political
 officials about person first language and make them aware of how hurtful these terms
 and labels are to impacted persons. She will gather information and plan to
 implement this after this election cycle.
- 8. No More Silence Project Betty B.
 - Betty has received responses from several members who have offered to help with reviewing the stories that have been submitted.
 - Shawn is reviewing the introduction letter that will be sent along with the stories that have been collected.
- 9. Social Media Team Rita B.
 - The team met on 8/13/2024 with the AP team regarding FB membership procedures and processes.
 - The SM team encourages productive advocacy posts and comments that are helpful to members.
 - Future meetings will be held quarterly.
