New information regarding contacting the BOP!

The Federal Bureau of Prisons (BOP) has established Regional Support Coordinators who are tasked with fostering a higher level of communication and transparency by addressing concerns raised by family members and advocates regarding the provision of adequate resources to adults in custody. These Coordinators serve as liaisons among the BOP Central and Regional Offices, institution employees, adults in custody, family members, and external stakeholders.

If you have been frustrated with getting in touch with federal prison officials, you can now contact any of these Coordinators, whose job it is to address your concerns! They are expected to respond both to individual issues as well as concerns regarding prison systems.
