- 6. Communication Team (CT) Kathy DV.
 - Member Brenton T. wrote a letter responding to an interview with Senator Whitehouse (RI) on "<u>Democracy Docket</u>". The senator discussed the need for the Supreme Court to use facts and research to make rulings. Brenton's letter presents the harmful effects of rulings on sexual offenses based on emotional fears and not on research. The team is reviewing the letter, will work with Brenton on editing and sharing the letter, and it will also be mailed under the UV4SOR umbrella.
 - The team is working on email and letter inquiries that come to UV4SOR from those who are incarcerated. The goal is to have a variety of templates to choose from depending on what is being requested.
- 7. Call to Action (CTA) Shawn L.

CTAs were explained and encouraged. Past CTAs can be viewed on the website.

- UV4SOR received a letter from the BOP in response to our CTA regarding TRULINCS. Shawn is working with the Communication Team to draft a response letter to the BOP.
- Sharon M. discussed an email response that she received from a BOP Support Coordinator from her inquiry for clarification of the BOP's new policy on phone minutes. - 8. No More Silence Project Betty B.

The project's introduction letter is finished, and Betty is reviewing suggestions for the list of recipients. Betty invited anyone to contact her with any additional names to receive the stories.

The group has a total of 22 volunteers for the 2024 Christmas Letters and Season Greetings campaign who will mail greetings to 54 incarcerated loved ones. All the instructions and information were emailed to the volunteers on 10/14/2024.

 - Rita's consignment check has been received and she will drop off more items in November.
 - The Tru-Earth fundraiser campaign is offering a 20% off sale and UV4SOR receives a 20% commission.
 - UV4SOR received a check from Kroger/King Soopers from member's purchases. Questions were answered regarding signing up through the Kroger app.
