- 7. Call to Action Team (CTA) Shawn L.

- 8. No More Silence Project Betty B.
 - This ongoing storytelling initiative collects personal accounts from individuals and families impacted by incarceration, the registry and related laws. The goal is to give voice to those who are often unheard, using their real-life experiences to advocate for change. These stories are shared anonymously or with permission with lawmakers, media, and the public to build empathy, challenge stigma, and influence policy reform. Members are encouraged to participate or help others share their stories.
 - The team has mailed seven packets of letters along with an introduction letter from UV4SOR. Betty will follow up with another letter to the recipients this month.
 - The group discussed possible influential recipients such as other organizations or pastors who may be willing to engage their congregations.
