### Group Discussion

1. Meeting called to order at 7:38 PM EST and review of last meetings – Group

2. Non-Profit Organization Updates – Shawn L., Executive Director
  - Board members meet monthly to collaborate on organizational business, review current projects, and work on processes and applications to be implemented.
  - The NARSOL [conference](#) in Atlanta, GA was held 10/16-19/2025 and there were no incidents from Proud Boys or any other organizations and security was visible. There were many opportunities to meet and interact with attendees and speakers. The next conference will be in June 2026, Baltimore, MD and everyone is encouraged to attend.
  - The National Coalition Against Conviction Registries (NCACR) did not meet in October due to the NARSOL conference.
  - National Government Relations Committee (GRC) is a national organization working at a federal level. It is currently on hold due to the government shutdown.
  - An update from Jay regarding the podcast is tabled.
  - The next board meeting is scheduled for 11/9/2025.
3. Advocacy Participation Team (APT) – Rita B.  
There are 32 members who have volunteered to mail annual Holiday Greeting letters to recipients. Participants volunteer to send holiday greeting letters to incarcerated loved ones.

The team reaches out with an email to new members who have attended their first meeting to welcome and encourage them, give helpful information for resources, to support them, and to answer any questions they may have. 6. Communication Team (CT) – Kathy D.V.

- The team will meet to review 2025 and look at the directions for 2026.
- Gail L. is writing to the Illinois General Assembly regarding “negligence hiring” challenging the premise that a company can be held responsible for hiring an employee with a criminal conviction.

7. Call to Action Team (CTA) – Shawn L.

- The team plans to meet in one week to prepare a CTA to be mailed when the government shutdown is over on the issue of discrimination against those who are incarcerated in federal prisons due to a sexual offense who are routinely denied access to the TRULINCS/CorrLinks messaging system. Letters and emails will be sent to the BOP, DOJ, and various legislative committees. Template letters and contact lists will be provided to members asking them to participate in this CTA.
- Shawn discussed a CTA to write to Attorney General Pam Bondi regarding the connection of identifying information of individuals on the sex offense registries to the safety of ICE agents at risk with apps identifying where they are located.
- Don C. has offered to write a CTA to the committee of Veteran Affairs in response to a bill to remove buried vets who have sexual offense records.
- The team is asking for volunteers to assist teams and members in bringing forth and presenting action items to the group along with providing direction for resources and contacts. Please contact [smonroe@uv4sor.org](mailto:smonroe@uv4sor.org) if you are interested!

8. No More Silence Project – Betty B.

- Betty provided an overview of the project which is an ongoing storytelling initiative to collect personal accounts from individuals and families impacted by incarceration, the registry and related laws.
