 - 4. three minute elevator speech is your name, your why and contact.
 - 5. Get your personal cards, Vistaprint has reasonable pricing. Include our logo!
- 7. Review Open Task issues and made updates.

Roundtable:

- 1. New Member introductions.
 - a. Annette has a brother incarcerated for the last 4 years. She tries to help as much as she can. It's not easy. She is learning a lot and wants to learn more about many different situations.
 - b. Paulettra lives in Virginia and her son is in BDOC for SO and her husband is also incarcerated. In both circumstances, the charges are being excluded and not talked about at the government level. She is the founder of Sister's For Prison Reform to get violent and SO crimes added to legislation and bills. No matter the offense, people deserve to be respected and treated humanely.
 - c. Ken was recently incarcerated for 30 months in the Federal system. He likes our approach to help people currently in prison. It makes all the difference in the world having someone to reach out to while serving your time. Mental Health is a hot topic in how it impacts people. The system hurts everyone's mental health and it is very difficult to deal with when you have a label once you are out.
- 2. If time share "something good!"
 - a. Page came across an announcement with 3 representatives; Matt Guess, Marjory Taylor Green and one other person. They visited a local DC prison and attempted to go in and tour the facility but were not admitted past the entrance doors. They asked to speak with a supervisor and were told she was outside. Once outside the doors were locked behind them. This group is planning a full investigation on the facility and plan to do this on all of the facilities.
