- ii. Dawn mentioned Andy was transferred to his program. Some of Dawn's fears caused by things being said about the building were put to rest, thankfully. They gave Andy a timeline and depending on how well he does in the program he can be there 8-12 months.
 - 1. He can be home anywhere between May and September of next year! ⁽²⁾
- iii. Jenny, mentioned her son was promoted. One more step in making more money!
- iv. Gail shared a comment about Chad by asking a question to the group: Does anyone else look at Chad Marks and see Curly from The Stooges?, Iol ☺. The group decided there was a resemblance! ☺
- v. Don/Shawn: An accidental criminal. Gabe was sharing a conversation he had with an older person who friended Gabe. He told Gabe he shouldn't be here, you must be an accidental criminal. Shawn thought about this term and then the light went off, probably 90% of the people who are incarcerated are accidental criminals. What a great way to describe what people are going through to give that human aspect. Don mentioned a lot of these crimes are one-time mistakes.
