 - More research is needed to ensure everyone involved is protected and to release liability from the website or web designer and those being released with parole responsibilities.

 - iv. We had an email inquiry from the website! Not a lot of information was provided although they are interested in our organization.

 - ii. A typo was found AFTER we sent the letter. On the letter where it states "FROM" it reads United Voices for Sex Reform. We need to be hyper vigilante in proofing our work! Very good lesson learned.

 - ii. Kathy, Jenny and Gail are meeting on 9/25 in person to create a letter using information from the Sex Offender Management Planning Initiative summary.
 - iii. A possible rebuttal on the SMART report per the DOJ by the American Law Institute, dated 5/14/2021 was found by Kathy. The rebuttal states why they are not using the report for further action. Kathy will send the report to the group for review/discussion to ensure this report aligns to the SMART report although it may not.
 - iv. Kevin Ring sent an update on the CARES ACT. He indicated the act is waiting for final Senate approval.
