- Fundraising Committee:

- Guest Speaker Anthony Gay:
 - Jenny spoke with Anthony. He has a court hearing on 1/29 and will follow up on the possibility of being a guest at one of our upcoming meetings, possibly in mid-February. Sixty Minutes wants to do a segment with him!
- Liability Release Form for Website Photos:

 - We have not had any new responses about submitting photos.
- Holiday Card / Letter Campaign Update:
 - This campaign was a big success. We had a great response to contributing with this effort and many who sent cards and letters received thank you notes from those who received them. We are making a difference to those who are incarcerated; their thanks indicated their joy in receiving this type of correspondence, it was uplifting to them, and they feel like what we are doing is important and makes a difference to them!
- Smart Office/DOJ Writing Campaign Update:
 - We had a response from the USSC (United States Sentencing Commission) from our letter campaign regarding the SMART report.
 - Their letter acknowledged receipt of our letter and said that "public comment regarding sex offenders and criminal justice reform should be directed to our local representatives".

- The response letter also indicated that the Commission periodically reviews comments and recommendations from the public regarding potential changes to the federal sentencing guidelines. We can discuss responding to them with questions regarding this process and ask who submits the comments and recommendations to them for review – and point out their use of the term "sex offenders"!
- Their letter was addressed to Shawn since her name was not signed on the letter that we sent to them, that means that they had to look at our website to get her name!
- Loved Ones FAMM Storytelling Update:
 - Betty was unable to attend the meeting, we will follow up with her at the next meeting for clarity of vision on this project and discuss the options that were brought up at our last meeting.
- Page has not received any response from Senator Kennedy as the Senate is heading into session. Jenny got negative feedback about him that he is all talk and no action, so we will postpone or redirect our efforts in this area. There is no follow up yet from Dr. Peter R. Breggin.
- Sharon brought up a letter writing campaign to address the issue of the upcoming change of leadership in the BOP. Both the current director and deputy director have resigned. This is a good opportunity for us to express our concerns about the BOP and make suggestions about the qualifications needed in new leadership.
 - Sharon will share her initial letter and send it to others who volunteer to contribute and review.
 - We will research to find out who makes the decisions about hiring new directors and create a contact list.
 - A letter can be sent from the group to each contact, and we will provide a template of the letter and the list of contacts for group members to send individual letters as desired. We will post to the Facebook page and encourage participation.
- Shawn discussed an upcoming webinar being presented by One Standard of Justice. The topic is "A Different Approach to Sex Crimes: The Case for Survivor-Centered Restorative Justice".
 - We will postpone our next meeting for one week as this webinar is on our next scheduled meeting night of 1/25/22. Shawn will post the details to the Facebook page and encourage everyone to watch it.
