Fundraising Update:

- Pammy and Sharon introduced the idea of soliciting recipes from our LO to be incorporated into a recipe book which can initially be on our website with a later plan to publish. We will add this to our Action Items.

Guest Speakers Update:

- Jenny is keeping in touch with <u>Anthony Gay</u>, <u>Tosha Smith Mills</u>, and <u>Chris Pelloski</u> on the possibilities of them being a guest at one of our upcoming meetings.
 - No change in progress with Tosha.
 - Chris is still pondering the possibilities with us as he determines his legal obligations.
 - Anthony is holding a zoom meeting on Tuesday, March 8, topic is "The Fight for Social Justice". Jenny will email and post details.

Loved Ones Storytelling Project Update:

- Betty is working out details to form a committee for this project and to determine a priority list for the various stages to implement the project.
 - Kim, Lisa, Patricia, and Pammy are interested in joining the committee to help with developing the vision and create a solid foundation for the campaign.
 - This is a huge opportunity for awareness and education. The basis for changes in legislation is to humanize the issues we are concerned with along with providing researched facts and statistics regarding the registry, sentencing, and incarceration.
 - This will be an ongoing project with the committee and group members involvement.

Communications Committee Update:

- Gail and Sharon reported that all three of our Call to Action (CTA) letters have been mailed to all contacts. Individual versions of each letter are posted on the website and group posts were made encouraging members to send the personal letters made available to them.
- Discussion about providing versions of these letters on the website which can be sent to our LO so that they can also participate in mailing. This idea was well received and will be further discussed in the Communications Committee.

Committees Discussion:

- Shawn reported on our need to create more committees to help delegate tasks and responsibilities for advocacy CTAs and to encourage member participation.
 - Suggestions for the type of committees needed include Research (for project support), Fundraising, and Marketing/PR (for developing media contacts and lining up speakers and guests for our meetings).
 - We will need committee heads and volunteers for each committee. This will be an ongoing process with group involvement and ideas to encourage group members to become more proactive in our projects.
- Group members who participated in sending letters to Amy Dickinson (the syndicated columnist who gave uninformed advice in her national column) reported that none had received any response from her.
- Shawn discussed the emerging need for moderators for our Facebook group due to the growth we are experiencing. We need to make sure that our group/page stays consistent with our advocacy focus.
 - Kimberly, Nafisa, and Jackie have volunteered to be Moderators, thank you!
 - Admins will develop guidelines for the Moderators and add them as such to the group.
 - A post will be made in the group identifying and welcoming the new moderators.
- Shawn received notification from Caution Click that they had utilized our First Step Act <u>individual scripted letter</u> for a mail blast from their group. Our website and letters are gaining the attention of other groups. Shawn will follow up with them to see how they came across our letter and how we can effectively work together in the future.

- An email was received from our "Contact Us" link on the website from a man with an inquiry about resources for employment.
 - Suggestions were received from Ken and Pammy who will forward information to Shawn on "Honest Jobs" and "Fair Shake".
 - Sharon will reply to the inquiry with this information and an invitation for him to attend our meetings and to keep us informed of his progress.
 - Discussion on developing a page on the website for reentry/employment and legal resources.
- Discussion about the current Supreme Court nominee <u>Kentanji Brown Jackson</u>.
 - Gail brought up researching more about this candidate's views on the registry
 after reading and posting an article about how she "once argued that the
 judicial system is unfair to sexual predators" and if this article's headline is
 misleading.
 - Jenny will follow up with Illinois Voices and NARSOL to clarify what actions they are contemplating and what their views are as we consider further research and weigh potential group actions and consequences regarding advocacy on this nominee.
- Feedback on our guest speaker at our last meeting, Derek Logue from Once Fallen, was positive. Comments were that he is driven, he has tenacity and keeps on fighting. Having diversity with our guest speakers is valuable and educational for all of us. Shawn did a great job of moderating the meeting and keeping the discussions on track.
