   Melanie showed the <u>recent FSA revisions</u> and the convoluted pathway to assess a person's <u>PATTERN</u> score, including undermining a better score. Discussed working with the communication committee to address the experts who gave the recent recommendations to evaluate pattern scores.
- Fall 2022 speaker Melanie H.
   Dr. Newsome wrote, "Finding Peace in an Imperfect World" and works with individuals who have been sexually abused and seeking to heal. A significant amount of his work is on forgiveness. Melanie is seeking input from the group to give Dr. Newsome direction on topics we may be interested in hearing and learning.
