Walt is a contributor to FORBES Magazine and New York University School of Law on criminal justice and federal prison issues. He often has articles cited in legal briefs regarding the conditions and shortcomings of the BOP (Federal Bureau of Prisons). Walt is the founder and president of Prisonology, LLC which is an expert firm with a concentration on policy related to federal incarceration. His firm consists of retired BOP and US Probation professionals who provide expert testimony, declarations, consulting, and training on BOP policies.

- Walt's presentation gave an overview of his firm and the types of issues they deal with for clients facing various charges and imprisonment and for those who are incarcerated. He and his team work with public defenders and criminal justice advocates to educate them about various aspects of how to effectively fight for change and understand the current culture of our legal system.
- Walt discussed challenges within the BOP, including poor execution of policies, overcrowding and staffing crisis, aging facilities, medical care, and inability to implement the FSA (First Step Act). Problems of overcrowding, particularly in BOP Low facilities, are due in part to the closing of private prisons and the increase in population.
- Valuable sources of information include <u>OIG</u> (Office of Inspector General) reports, <u>USSC</u> (US Sentencing Commission), <u>GAO</u> (General Accountability Office) reports, <u>BOP Legislative Affairs</u>, and <u>court cases</u> with successful outcomes. Media sources include <u>LisaLegal</u> and <u>The Marshall Project</u>.
- 3. Group question and answer session and discussion.

Various questions were asked throughout Walt's presentation, and he is very engaging and knowledgeable about the problems facing not only the BOP and state prison systems but also the problems of those incarcerated and their families in dealing with all aspects of the judicial system, prisons, rehabilitation, and reentry.
