- 1. Non-Profit Shawn L.
 - The Non-Profit Certification is still pending and should be completed by the end of next month.
 - The next board meeting will be on Sunday 2/26/2023.
- 2. Upcoming Speaker/s Shawn L.

<u>Dr. Stephanie Jerstad</u> from Millersville University in PA will be our speaker on February 21, 2023. Her <u>dissertation research</u> at Southern Illinois University focused on the willingness of long-term care facilities to accept persons convicted of sexual offending into their care as residents.

- 3. Advocacy Participation Committee and State Coalitions Update Kim H.
 - Kim H. reviewed and updated the progress on the Advocacy Participation Committee's
 efforts to contact all members of the FB group to obtain email addresses and state
 information. This information will feed into support of the State Coalitions.
 - The State Coalitions project currently has state leaders for seven states: NC, SC, IL, IN, TX, along with newly added PA, and OK.
 - The first State Coalitions meeting with five states represented was held on 1/23/2023 to discuss information to use as a foundation for future states and brainstorming with the current state leaders.

- 4. Illinois Legislative Leader Meetings Gail L. and Kathy D.
 - Gail had a Zoom meeting with a State Representative after following up on a previous email she had sent and received a reply to. Kathy had a Zoom meeting with an aide/case management person from Dick Durbin's office. Both Gail and Kathy had notes and a list of talking points. The group discussed the importance of making initial contact with legislative leaders, making them aware of our group and our goals, and realizing that this is the first step of an uphill battle with political leaders. Shep and Ann share that they are working to make contacts in NC and become involved in the legislative process there.
- 5. Communications Committee Update Gail L.

The Communications Committee had a meeting in January to set goals for 2023. Some of the items that will be addressed this year include following up with the ALI regarding their recent model penal code revisions to sexual offenses, preparing fact sheets and educational letters, sentencing disparities, and second chances. The committee will focus on current issues that relate to sexual offense reform and initiate calls to action as needed, share contact information and sample letters for advocacy, and encourage members to personally address current issues that aren't necessarily specific to sexual offenses but seem to disproportionately impact those with these charges.

6. General Meetings Inquiries - Shawn L.

The question of recording our meetings has been asked several times in the FB group. The group and board had previously discussed this and decided not to record meetings due to privacy concerns and the importance of the safety of members who may share sensitive and personal information in the meetings. It was also noted that some guest speakers do not want their presentations recorded for various reasons including copyright concerns. We eventually want to transition away from social media and make more information available through our website.
