- 1. Non-Profit Shawn L.
 - The Non-Profit Certification is still pending. Shawn will contact the IRS next week to inquire about the status and find out if we need to do anything to expedite it.
 - The next board meeting will be on Sunday 4/23/2023.
- 2. Advocacy Participation Committee Kim H.
 - Kim reported on engaging members from Florida and asking for their help in the CTAs
 for the multiple bills being presented there. She discussed the committee's goal to
 engage members and the focus on contacting non-state coalition members.
 - Efforts are continuing to communicate with members who post in the FB group, directing them to other members in their state for resources and to promote participation in calls to action when needed.
- State Coalitions Committee Kim H.
 - The State Coalitions project currently has state leaders for seven states: AL, IL, IN, NC, OK, PA, and SC.
 - The State Coalitions group will hold their next meeting on 4/24/2023.
 - State Coalition leaders will discuss methods of identifying members who want to advocate.
 - Once members have expressed an interest in our advocacy efforts, they will be contacted about our activities and asked if they would like to become more involved by being a state coalition leader.

Communication Committee – Gail L.

Gail reported that the committee has sent letters in response to the Florida "Red Letter" and Vacation Rental bills currently being reviewed in the FL House and Senate. Additional letters and emails were sent in coordination with the CTA committee. The committee's current project is to coordinate with the State Coalitions and address the legislative members of the federal Second Chance Task Force.

5. Mental Health Committee – Pammy D.

The committee holds meetings every other week. Their last meeting was on 4/2/2023. They are working on an introduction mental health paragraph and biographies of each committee member. Their goal is to create a new type of holistic mental health treatment.

6. No More Silence Committee – Sharon M.

This story telling project has been launched with an announcement in the FB group and has been added to the <u>UV4SOR website</u>. Betty will make ongoing posts in the group to encourage participation. Shawn L. and Sharon M. will review the project introduction and will send an email to all members on the contact list. Stories from LO and family members about any aspect of the processes involving sexual offense charges are welcomed.

7. Fundraising Committee – Rita B.
