Group Discussion

- 1. Review of Last Meeting Group The 5/16/2023 meeting minutes were approved and will be posted on the <u>website</u>.
- 2. Board Updates Shawn L., Executive Director
 - Board members are working on previously tabled projects and making good progress.
 - All committee titles have changed to "Teams" and chairpersons are "Team Leaders".
 - The next board meeting will be on Sunday 7/9/2023.
- 3. Advocacy Participation Team Kim H.
 - Kim reported that we have received numerous new requests for membership to the FB group after we were mentioned in another support group.
 - The welcoming group is implementing a 7-day response time for those requesting membership to reply to the email they receive with the vetting questions.
- 4. State Coalitions Team Kim H.
 - The State Coalitions team leaders held a meeting on 6/5/2023.
 - The group finalized their survey questions and will include an introduction and conclusion section. They will share the questions and reach out to others who have offered help in reviewing and the survey and will then present it to the board.
 - A new member, Jenn M., will work with Betty B. as a co-leader for Indiana.
 - The next team meeting will be on 7/10/2023 at 7:00 p.m. EST.
- 5. Call to Action (CTA) Team Elena A.
 - Elena reported that the Florida Action Committee (FAC) has listed UV4SOR as an advocacy partner.
 - The team is working to address Michigan's law that requires a lifetime tether and will reach out to Kim H. to inform our Michigan members. The committee has drafted a letter regarding changing the language of the law and addressing a pathway for relief from the lifetime requirement.
 - The team plans to develop a platform for addressing candidates who will be running for office in upcoming elections.

- A new CTA is being prepared to address concerns with an <u>article</u> that was published by Atavist Magazine which disparages and marginalizes our population and loved ones. A CTA letter to FAMM will be posted in the FB group and sent to members via email. The Communication Team will send a similar letter to the author of the article as part of our mission to educate the public and other advocacy organizations who purport to advocate for criminal and social justice reform.
- 6. Communication Team Gail L.
 - Gail reported that the team is sending an introduction/welcome letter to the new president of Women Against Registry (WAR).
 - The team works as UV4SOR's strategic arm in conjunction with the CTA team acting as tactical response and support of our organization's mission.
- 7. Fundraising Team Rita B.
 - The fundraising project with Avon has concluded and funds raised have been received and deposited.
 - Future fundraising projects are being reviewed.
- 8. Mental Health Team Pammy D.
 - The MH team held a meeting on 6/11/2023.
 - They have developed 10 interview questions for anyone interested in joining the MH team to ensure that qualifications and values align with their mission and vision.
 - Two members of UV4SOR have been interviewed and will be accepted to join the team. One person has a legal background and the other has mental health experience.
- 9. No More Silence Team Betty B.
 - Betty reported that no new letters have been received. Discussion ensued about how to encourage people to tell their stories and how to address potential fears they may have about sharing information.
 - Stories can be any length and can be kept anonymous. Betty will start to post regularly in the FB group to encourage participation and recruit volunteers for the team.
 - Betty is developing an introductory letter for a packet in anticipation of sending copies of the letters to legislators.
- 10. PR/Marketing Team Shawn L. and Jenny L.
 - Two speakers are confirmed for upcoming meetings.
 - Licensed psychologist Dr. <u>Keith Hersh, PhD</u>, will be our guest at our next general meeting on 6/27/2023. He will discuss his practice, which involves treating persons with sexual behavior problems, and his experience working with the NC Department of Corrections.
